#### **SAFETY RULES:**

- 1) The fencing floor is a restricted area and only fencers may be on it. Non-participants must stay in the observation/seating area.
- 2) Fencing weapons must be carried point down or in a fencing bag.
- 3) No type of movement with the blade is allowed if any person within 4 feet of action is not wearing a mask
- 4) Warm up stretches are required before a lesson or practice.
- 6) All owned or rented gear **MUST** be worn while in class.
- 7) Unsportsmanlike behavior and rough play or actions, whether intentional or not, are prohibited in class
- 8) All fencers have a duty to report any unsafe area or unsafe activity to the staff.
- 9) Any illness, injury, or the taking of medication must be reported to the front-desk staff member and/or the instructor before class/lessons or practice.

**COVID SAFETY RECOMMENDATIONS:**

- 1) All members of Staff/Coach/Fencers/parents and/or guardians, who enter the facility MUST wear their mask/facial shields.
- 2) All members of Staff/Coach/Fencers/parents and guardians will be temperature tested at the entrance of the building, and hands will be sanitized.
- 3) All coaches giving instruction/private lessons are required to wear a mask/facial shield
- 4) All Administrative staff providing services to fencer(s), parents and/or guardian(s) are required to wear a mask or facial shield
- 5) Fencer(s) will be placed in a group consisting of no more than 10 fencers
- 6) **NJFA/USFA/CDC & WHO**, suggest fencers wear a mask under there fencing masks, during private lessons and fencing classes
- 7) Fencer(s) once registered to take group classes, can rent entire equipment for the class at a cost of \$25 per month. (Weapons are to be left at the club)
- 8) Parents/Guardians who have fencer(s) in Beginner; Intermediate; & Elite classes MUST drop-off fencer(s) at the door. However, parents/guardians who are registered for “Introductory”, “Private” lessons or scheduled for a 1<sup>st</sup> time Free Consult are permitted to stay and observe for a 20minutes session.

**Equipment must be taken home after each class. (Weapons will be given to the front desk for sanitizing after each class).**

**Due to Covid19 Safety Measurements, we will no longer rent Metallic Electric Jackets they will have to be purchased. Effective October 1<sup>st</sup>, 2020**
